14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On July 10, 2013 ("Distribution Date") Retail Properties of America, Inc ("RPAI") paid a distribution in the amount of \$0.165625 per share to its shareholders of record at the close of business June 28, 2013.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ A portion of the distribution paid on the Distribution Date may not be paid out of RPAI'S earnings and profits and thus may be considered a non-dividend distribution. A non-dividend distribution reduces the shareholder's adjusted tax basis of RPAI stock.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ On the Distribution Date, RPAI cannot determine the percentage of the distribution that is considered a non-dividend distribution. At the close of the current tax year, RPAI will calculate its earnings and profits, which will determine the percentage of distributions paid out of earnings and profits and the percentage of non-dividend distributions.

17 List the applicable Internal Revenue Code section(s) and subsection(s) upon which the tax treatment is based ▶ Internal Revenue Code ("IRC") Section 301(c) states the portion of the distribution which is dividend (defined in IRC Section 316) is taxable and the portion of the distribution which is not a dividend shall be applied against and reduce the adjusted basis of the stock.

18 Can any resulting loss be recognized? ▶ Pursuant to IRC Section 311, a distributing corporation will not recognize a loss on a non-liquidating distribution of property. A shareholder receiving a non-liquidating distribution of property from a corporation will not recognize any loss on such non-liquidating distribution of property.

19 Provide any other information necessary to implement the adjustment, such as the reportable tax year ▶ The final computation of earnings and profits for the tax year ended December 31, 2013 will be computed during January 2014. At such time, the percentage of the distributions paid out of earnings and profits and the percentage of non-dividend distributions will be computed and disseminated to the shareholders of RPAI.
